

Arabia Offscreen | 2011 Journey to Saudi Arabia

Competition Terms & Conditions

Who can apply?

The competition is open to residents of the UK, UAE, Qatar, Egypt and Malaysia, who must be aged 18-24 by December 2011.

Start Date

The competition will run from 7th May – 1st August 2011.

How to Apply

Application is through the website www.arabiaoffscreen.com. Go to the 'Apply now' page and complete all the sections of the form. Entrants will also need to upload:

- An artwork (for example a painting, drawing or collage)
- A film (for example a video diary, documentary or animation)
- A photograph or series of photographs

Each applicant must only submit one entry (i.e. one entry form per applicant). There are no restrictions on the total number of applicants that will be accepted.

All entries will be uploaded via the website so there will be no return of entries.

By submitting an entry, applicants absolutely assign with full title guarantee all and any intellectual property rights throughout the world in the Competition Work to Offscreen without restriction

The Prize

10 winners will win a place on an expedition to Saudi Arabia which will take place in December 2011. There is no cash substitute to the prize.

The expedition is fully funded. Applicants will however be responsible for their own travel (including costs) to interview (held in the UK, UAE, Qatar, Egypt and Malaysia). Winners will be responsible for (including costs) their travel to and from the airport before and after the expedition. During the expedition all travel, activities, accommodation as well as food and drink will be provided.

The expedition will run from 1st – 17th December 2011.

Restrictions

Applicants cannot participate if any of the following apply:

- They do not have a valid passport at the time of selection
- They are over the age of 24 by December 2011
- They are under the age of 18 by December 2011
- They cannot speak English
- They are not resident in the UK, Qatar, Egypt, UAE, or Malaysia

Applicants will also need to have access to the internet in order to apply online.

How will the competition be judged?

There will be an independent (i.e. independent of the promoters/organisers) judging panel consisting of 4 individuals in the creative fields.

1. **Initial Shortlist:** A shortlist of 50 applicants will be made by Offscreen from the total submitted applications (for each country)

2. **Interview Shortlist:** Judges will choose 10-20 candidates of these 50 and invite them for interview

3. **Interviews:** Interviews will then take place in August 2011. Interviewees will be asked to present their entry within a 5-10 minute presentation followed by questions.

Criteria for judging entries will be based on the following:

- **Artistic Skill:** level of technical skill relating to the medium of application
- **Artistic Presentation:** level of creative and aesthetic competence
- **Inspirational:** how inspiring is the work to other young people
- **Original/Authentic:** local/regional specific
- **Relevance to Creative Industries:** how easily could the work translate into the real world

Notification of winners

The ten winners will be notified by phone and email by the end of August 2011. The prize is received when the expedition (the prize) takes place in December 2011.

Announcement of winners

After the winners have been notified there will be an announcement of their names, where they are from, and ages (no other personal information will be revealed in the announcement). The announcement will be made in a press release and on the competition website.

Announcement will take place by the end of August (but only after the winners have been notified).

Winners may be called upon to engage in post promotion work which may consist of (but not limited to) media interviews.
